

He then served as the Hawai'i County Deputy Managing Director. This is third highest administrative position in Hawai'i County government; responsibilities included supervision over the administrative functions of all departments in the County, with a \$205-million operating budget and over 2,000 employees.

Following that, he was the Director of the Hawai'i Department of Land and Natural Resources (DLNR.) DLNR is a multi-faceted department with a \$100-million operating budget and nearly 1,000-employees, responsible for Hawai'i's natural and cultural resources, including public lands, water resources, ocean waters, parks, boating, ocean recreation, coastal programs, forests, wildlife, natural area reserves, etc.
